OUR HISTORY

In 1990, the first International Marine Surveying Conference sponsored by IMarEST and the Nautical Institute was held in London. Following this conference, a group of likeminded surveyors decided that their profession needed more recognition to meet the demands of the changing maritime world. In April 1991, over thirty surveyors from eighteen countries met at The Baltic Exchange. After a long meeting, the International Institute of Marine Surveyors was formed, more recently changing its name to the International Institute of Marine Surveying, or IIMS for short.

In the early years, the then President encouraged members of the Institute to set up education programmes for the training of marine surveyors; and so, a distance learning programme was launched which has become two Professional Qualifications in Yacht & Small Craft and Commercial Ship & Cargo marine surveying leading to a Diploma. In 2017 IIMS was recognised for the quality of its education programme when it was presented with an IMC Golden Shield Excellence Award and is widely accepted as an expert in the area of marine surveying training and education.

In 2004 the Institute became a Limited company. A new range of meetings, conferences, seminars, training days, courses and other support elements were developed for the benefit of the members which continue to this day.



In late 2014, the Institute's web site www.iims.org.uk was completely reconstructed from scratch and the foundations were laid for what is now the most valuable online resource to be found anywhere online for marine surveyors. Each month, on average, the site attracts 1,000,000 page impressions and over 15,000 unique visitors. There are more than 3,000 stories and features to browse, access to essential surveyor guidance, yacht codes, rare shipping regulations, videos, podcasts and much more. The website is constantly being upgraded to enhance the experience including page load speed, layout and design.

In 2016, the Institute celebrated its Silver Jubilee with a year-long celebration, culminating in a major London Conference and Awards Ceremony to recognise excellence in marine surveying and a sparkling Gala Dinner befitting the occasion.

In 2020 IIMS purchased Murrills House in Portchester UK as its permanent headquarters. This jewel in the crown, a delightful Grade II listed structure, can trace its history back 500 years and IIMS is pleased to be the present custodians of a heritage property so rich in history.

Over the years, the Institute has created formalised branches in Canada, India, Nigeria and UAE that arrange meetings and seminars for members locally.

The International Institute of Marine Surveying is an independent, non-political organisation. Its principal aims and objectives are:

- 1. To promote professionalism and the advancement of knowledge of the profession of Marine Surveying, which the Institute defines as being, 'the service provided to maritime and transport organisations in general and the production of guidance reports for all other bodies connected with maritime operations or maritime trade'.
- 2. To maintain high professional standards set out in a Code of Conduct and to verify the competence of those seeking to become members of the Institute.
- 3. To seek recognition from Government organisations, Coastguards, the International Maritime Organisation, licensed marine underwriters, insurance companies, ship owners and marine lawyers.
- 4. To put into practice and maintain the high standards of the Institute and consequently to exclude certain surveyors, or those whose conduct or competence could cast discredit on the Institute and the wider profession.
- 5. To confer professional status on those who contribute to and encourage safety, professionalism and unity amongst those concerned with the shipment of cargo, marine surveying, superintendency and marine consulting.
- 6. To bring together experts whose specialised knowledge and practical expertise will enhance the reputation of marine surveyors and consultants.
- 7. To bring together the marine surveying organisations of the world to create a single voice to Governments, International Bodies and the marine industry in general.
- 8. To set the standards for others to look up to, organise and evaluate the training and to promote the development and education of future marine surveyors worldwide.
- 9. The advancement and recognition of the reputation of the international marine surveying profession and its associated aspects by means of regular publications, communications and public meetings.

CODE OF CONDUCT

The basic principles expected of members:

Professionalism

A member must have a sound foundation in the general knowledge of his/her profession in addition to appropriate and adequate experience.

Objectivity

A member must adopt an impartial and objective approach in all aspects of his/her marine surveying work.

Independence

A Surveyor will be independent of the client commissioning the survey.

Professional Indemnity

The Surveyor member shall at all times maintain in force Professional Indemnity Insurance at a realistic level in accordance with the Surveyor's work and professional status. Members employed by surveying companies should ensure they are covered by the company PI policy before carrying out survey work.

Integrity

A Surveyor will:

- Not be influenced by outside pressures
- Not seek to reach agreements based on objective conclusions
- Will not make personal or illegal profit from the sale of damaged goods or materials

Non-Compliance

A Surveyor will bring to the attention to the Institute instances where members of the Institute are not observing this Code of Conduct.

Personal Conduct

A Surveyor will not practice during a period when his/her judgement is, or might be impaired through any cause and will endeavour to avoid actions, which lead to the discredit of the Institute, marine surveyors and his/her own professional reputation.

Client Relations

A Surveyor will:

- Never bias or modify his/her professional opinions for personal gain or in response to any form of pressure from whatever source
- Survey to principal clear terms of reference and confine his/her report to the agreed terms
- Only undertake to carry out assignments for which he/she is properly qualified so to do
- Accept arbitration when all parties involved agree to this method of solving disputes
- Recognise that his/her first duty is to his/her client's instructions and endeavour to sustain an open relationship with a client whilst, at all times, observing professional integrity

Professional Relationships

A Surveyor will:

- Co-operate with colleagues to achieve a complete and objective survey
- Not allow agreements reached by a Surveyor in charge of a case to be modified by the direction of any organisation to which he/she belongs
- Not criticise a fellow Surveyor or colleague to third parties
- Ensure strict confidentiality over information received from third parties who are not involved with the case in hand
- Not carry out free surveys but negotiate reasonable fees which seek to achieve full cost recovery
- Discuss with other attending Surveyors any contradictory statements or differences of opinion before issuing a final report

Standards

Where recognised, local, national or international authority standards exist and are in force for any type of survey, these standards shall always be observed. Any variance from these standards, together with the Surveyor's reasons for such variance, is to be fully recorded in the survey and the Principal's agreement obtained.

MEMBERSHIP RULES, OPPORTUNITIES & GUIDANCE

Membership Application

All applications to become a member of IIMS are subject to detailed review and approval by the Professional Assessment Committee before membership is granted.

Constitution

Membership of the IIMS is governed by its Constitution which has been approved by members.

Code of Conduct

Members are bound by the Institute's Code of Conduct (detailed elsewhere in this brochure). Disciplinary action may be taken against members who do not adhere to this code.

Annual General Meeting

Each year an Annual General Meeting is organised where voting takes place on specific proposals, re-election of IIMS officers and an overview of the Institute's trading performance and activities is presented. All members are entitled to attend.

Subscriptions

Membership subscriptions are paid in full annually at the beginning of each calendar year, or on a pro-rata basis if joining part way through the year. There is a modest non-refundable joining administration fee, and the full subscription does not become payable until an application is approved.

Professional Indemnity Insurance

The Institute Code of Conduct recommends all members to have PI insurance before they start surveying and in the case of UK small craft surveyors it is mandatory. IIMS organises special schemes for its small craft members through specialist insurers.

Technical Support

The Institute can provide a Technical Support contact through Head Office. This support is available to all members and can be on any marine surveying subject.

Conferences and Seminars

The Institute organises Conferences and Seminars on a worldwide basis. A full schedule of these events is published on the IIMS website and is notified to all members.

Working Groups

The Institute has a series of Working Groups that meet to discuss various topics. These working groups take place where required on an as and when basis.

Codes of Practice

Small Craft Surveyors work to a Code of Practice. See website for details.

Education and Training

IIMS has been formally educating marine surveyors for nearly 20 years and is the only professional body to provide Professional Qualifications in Yacht & Small Craft and Cargo & Commercial Ship Marine Surveying delivered through distance learning, leading to a Diploma. The Institute has also launched a standalone Professional Qualification in Marine Corrosion.

Through its subsidiary, the Marine Surveying Academy, the Institute offers short courses and accreditation schemes in multi marine disciplines.

Publications

IIMS publishes a popular series of nearly thirty handy guides covering various marine surveying topics. They are available in paperback and electronic format via the website. The excellent Report Magazine (nominated for a prestigious publishing award) is a quality and informative publication for members and is published quarterly, available to read in pdf or eReader formats from the website.

Continuing Professional Development

The Institute operates a CPD programme and members are encouraged to keep their CPD up to date. by using the free and easy to use App. It does not mean going on endless courses, nor does it mean being trained necessarily. However, it is about further developing your skills and competency to help you carry out your role as a marine surveyor to the very best of your ability and demonstrating that to the wider world. Institute Logo

As well as putting post nominal letters after your name, some grades of membership may use the IIMS logo on business cards, headed paper and also on a website. There are set criteria for the use of the logo.

CONTINUING PROFESSIONAL DEVELOPMENT APP

As with most other professional industries, IIMS members are encouraged to take responsibility for their own continuing professional development and need to acquire 15 CPD points each calendar year to remain up to date.

Once a member has gained 15 points the CPD icon will be displayed on their listing to show they are CPD compliant.

Earning 15 CPD points is not hard, and it does not mean having to do courses and attending training sessions. There are many ways in which points can be accumulated and the IIMS CPD Points Table can be found on the website.

The Institute has developed its own comprehensive and easy to use CPD App to enable members to easily keep their points current in real time as they are earned. There are Android and iOS versions available to download free and also a webbased application too.

Each IIMS member has a unique log in - email address and associated password - that is used to access their membership page on the IIMS web site. The same details give access to the CPD App. Members are encouraged to claim points in real time rather than saving up a claim for months.





All UK vessels in commercial use up to 24 metres load line length, which go to sea are required by law to comply with one of the Maritime and Coastquard Agency (MCA) Small Craft Codes. Vessels that meet the stringent requirements of MGN 280 code, or one of the other specialist small craft codes, or the Workboat 2 code, are issued with licence certificates by the IIMS Certifying Authority, which is approved under contract by the MCA.

IIMS Certifying Authority Registered Examiners are authorised to carry out vessel coding and compliance examinations for certification by the Institute. Once a member of the Institute you may apply to carry out coding examinations through IIMS.

The criteria for becoming an IIMS Certifying Authority Examiner is as follows:

- Applicants must be an IIMS member at the appropriate level.
- Applicants must be able to demonstrate through evidence at least three years surveying experience in all types of vessels (copies of survey reports may be requested).

The application form and relevant documentation will be reviewed by the Certifying Authority Committee and a date will be set for an interview, which is mandatory.

Workboats

The IIMS uses the "The Harmonised Code MGN 280" for vessel coding covering:

- Sailing charter vessels, both skippered and bareboat
- Motor charter vessels including angling and dive boats
- Motor vessels carrying up to 12 passengers
- · Pilot boats

The requirements for the use of each vessel are considered and the category approved will depend upon the nature of its operations, distance from a safe haven, limiting weather and whether overnight passages are to be undertaken.

Remote Tonnage Training

IIMS is contracted by the MCA to provide tonnage measurement training remotely leading to surveyors becoming authorised to carry out tonnage surveys. Occasional courses are organised. To become authorised, surveyors must complete Part I and Part II. Part I is a threehour online theory learning presentation. Part II requires the surveyor to provide suitable video evidence of a mock tonnage survey being carried out which will be scrutinised prior to awarding of the authorisation.

COMMUNICATIONS: REPORT MAGAZINE

The Report Magazine is the only publication of its kind serving the marine surveying Profession. It is published quarterly on the first day of March, June, September and December. Each edition extends to well over 100 pages. Much of the content has been specially commissioned for readers but members (and other interested parties) are encouraged to submit article for publication and some do.

Each edition of the Report Magazine is downloaded and read multiple thousands of times in pdf or eReader formats.


